Mrs. Leuk, School Counselor, reported on the 2025 Valedictorian and Salutatorian for both West Desert High and Tintic High schools.

Mrs. Leuk discussed data regarding student interventions and social emotional learning. Mrs. Leuk stated that grant money enabled the purchase and use of My Story Matters for help with the students. Mrs. Leuk stated that attendance is a huge issue and reported she is working with principals on how to improve attendance and instructional time for students.

Mrs. Elinda Nedreberg, Drama Teacher, reported the successes of Tintic students at the State Drama competition and presented two of her award winning students who performed short acts from their performances.

Superintendent Thornock reviewed the Big Idea activity from last year's Opening Institute, stating that the schools are looking at using the Canvas program instead of Google Classroom, which is also used by colleges. Superintendent Thornock discussed items from the Big Idea lists that have been completed and that he will continue moving forward with completing list items.
