We discussed the school improvement plan and how that will be our driving force when we create our school land trust plan later this year for next year.

We spoke of the current amount of \$80,000 that we are working with this year.

We discussed our parent engagement policy and our Student compact for success. These documents were shared electronically with Council for their review and invitation for them to share ideas on ways to improve those policies.

We shared 2018-2019 successes with the following statements:

Reading goal was 82% on or above or making a years progress. We had 77.5% on or above and with students making one year or progress we had 84.2% total. So with the Dibels measurement we met the goal.

With the F&P measurement on or above was 69.7% and then 11 others made a years progress which made the total 82%, so we also made it with that measurement.

In math the goal was 83% of students will be on or above grade level or make a years progress according to Moby Max (3-6) 74% or I-ready (K-2) 82.7%. When we put this all together, we ended the year at 79.1% of students were on or above grade level or made 1 years progress in math.

We introduced 4 amendment proposals:

#### Amendment Proposal

Our goal stated that we would purchase Mastery Connect to help teachers track student progress in each standard. The School District decided to purchase a similar program for all schools and we no longer need to purchase this. The amount budgeted for that purchase was \$5,000. We also planned on purchasing I- ready online assessment and supplemental instruction for \$4,000 that we do not need to purchase now because the vendor gave it to us with the 6 year purchase of Ready Math.

#### Proposed amendment:

Goal #1 We propose to pay \$490 for Math endorsement classes for Mrs. Haynes to finish her program. Also, with CC approval, Superintendent approval and School Board approval, re-imburse Mrs. Haynes for her classes toward this endorsement from recent fees associated with it for a total of \$515. So totaling \$1,005. We saved \$1,200 on the Rural Schools conference that would cover this cost.

#### Amendment Proposal

We plan on purchasing the Horizon Phonics program for about \$8,850. This proposal is made after looking closer at our current phonics instruction and wanting to add this piece to replace some older practices with more current and proven methods that this program will have. This includes training as well.

#### Proposed amendment:

At the end of the plan it is proposed that we include a statement in the funding changes section that states the possibility to use funds to support printing and copying to support our reading, math and science curriculum, lessons, and student materials.

We spoke of the student digital citizenship training that took place this past month from Brandon Harrison with Cues.

The council discussed the internet safety program and how the school addresses that with the student training from CUES and the district filtering abilities.
