The scores for reading for West Desert Elementary School are as follows. BOY (Beginning of the year) 43% of students were on or above grade level. EOY (End of the year) 60% of students were on or above grade level. That is an increase of 17%. Our reading instructional practices were looked at closely, and we did research and found the science of reading philosophy and began to adhere to that.
