No students took the ACT in the 2020-2021 school year, so comparing is difficult. When I look at the prior year compared to last year, so 2019-2020 and 2021-2022, the ACT composite results were very similar.

In the end-of-level data for WDHS, when comparing 2020-2021 with 2021-2022, There was an improvement in proficiency levels in Science but a decrease in proficiency levels in Reading. Both of these differences are very small. Math scores remained at the same proficiency levels for both years.
